Wedding Car Hire - Terms and Conditions

- i. A deposit of £50 per car is required to confirm a booking. Deposits are neither refundable nor transferable.
- ii. The balance of the payment is required at least 3 months before the commencement of hire. No monies are refundable nor transferable after this date, neither may the vehicle(s) be used for any purpose other than as specified in original booking.
- iii. Any alterations or cancellations must be notified in writing. If cancellations are made within 3 months of the date of the wedding date then the hirer is still responsible for the outstanding balance.
- iv. Our quoted prices are based on a maximum 3 hour hire period from time of arrival of the hire car at the pick-up address, unless otherwise agreed.
- v. Any additional costs incurred such as extra time, parking charges or deviation from the journey as booked in relation to the booking form (eg. to another destination for photographs) may necessitate the charging of an additional cost at the prevailing rates in half hourly increments pro rata. Any additional costs must be paid for in cash and in full before the end of the hire period.
- vi. Lawnswood Limousines accepts no liability for any unforeseen circumstance whatsoever eg. punctures, accidents, traffic jams or severe weather conditions.
- vii. Should a hired vehicle become permanently immobilised, Lawnswood Limousines reserves the right to provide an alternative vehicle; failure to do so will result in a full refund of monies paid for that vehicle, thus ending Lawnswood Limousines' liability.
- viii. Lawnswood Limousines cannot be held responsible or liable for loss or damage to the hirer's property, luggage or personal effects howsoever it may be caused.
- ix. Lawnswood Limousines accepts no liability for clothing or any object being marked, dirtied or damaged in any way during the duration of the hire.
- x. Hirers will be held responsible for any damage to the vehicles howsoever caused by the clients or their guests regardless of cost, including but not restricted to damage such as stains, cigarette burns or fabric damage.
